### **EXPUNGEMENT INSTRUCTIONS**

[La. Code of Criminal Procedure Article 983 et seq, Effective August 1, 2020]

#### \$550.00 (Felony or Misdemeanor)

Provide completed forms along with payment to the Jefferson Parish Clerk of Court. Payment may be made by U.S. Postal Service money orders or money orders issued by any state or national bank, or by checks issued by a law firm or an attorney. **TWO** payments are needed, including **\$300.00** payable to "Jefferson Parish Clerk of Court," **AND \$250.00** payable to "La. State Police." The amount payable to the Jefferson Parish Clerk of Court may also be paid in cash, or by personal or business check. Credit cards are not accepted for expungement fees.

#### \$600.00 (DWI)

Provide completed forms along with payment to the Jefferson Parish Clerk of Court. Payment may be made by U.S. Postal Service money orders or money orders issued by any state or national bank, or by checks issued by a law firm or an attorney. **THREE** payments are needed, including **\$300.00** payable to "Jefferson Parish Clerk of Court," **AND \$250.00** payable to "La. State Police," **AND \$50.00** payable to "La. Office of Motor Vehicles." The amount payable to the Jefferson Parish Clerk of Court may also be paid in cash, or by personal or business check. Credit cards are not accepted for expungement fees.

Fees are distributed as follows: La. State Police, \$250; Jefferson Parish Clerk of Court, \$200; 24th JDC District Attorney, \$50; and Jefferson Parish Sheriff, \$50. If DWI, an additional \$50 is provided to the La. Office of Motor Vehicles.

#### ALL FEES ARE NON-REFUNDABLE, EVEN IF EXPUNGEMENT IS DENIED.

Motion for Expungement—Return the original form with 2 copies. Motion for Interim Expungement—Return the original form with 2 copies.

NOTE: Applicant will not be required to pay filing fees if he obtains a Certificate of Fee Waiver from the District Attorney's Felony Records Division, 200 Derbigny St., Gretna, stating that applicant has no felony convictions or pending felony charges under a bill of information or indictment and at least one of the following applies:

- a. Applicant was acquitted, after trial, of all charges derived from the arrest, including any lesser offense;
- b. The district attorney consents, and the case against applicant was dismissed or the district attorney declined to prosecute the case prior to the time limitations prescribed in Chapter 1 of Title XVII of the Code of Criminal Procedure, and applicant did not participate in a pretrial diversion program;
- c. Applicant was arrested and not prosecuted within the time limitations prescribed in Chapter 1 of Title XVII of the Code of Criminal Procedure and did not participate in a pretrial diversion program;
- d. Applicant was determined to be factually innocent and entitled to compensation for a wrongful conviction pursuant to the provisions of La. R.S. 15:572.8.

Applicant must obtain a Review of Record from the Jefferson Parish Sheriff's Office, 1233 West Bank Expressway, Harvey, LA 70058, (504) 363-5541. The fee for this service is \$50.00 (NON-REFUNDABLE)[CASH ONLY]. **The Review of Record must be obtained within 60 days prior to filing the expungement.** 

\*\*\*The Jefferson Parish Clerk of Court's Office is prohibited by law from providing legal advice. This office cannot assist applicant in completing expungement forms. Applicant must complete forms or seek qualified legal counsel for assistance.\*\*\*
